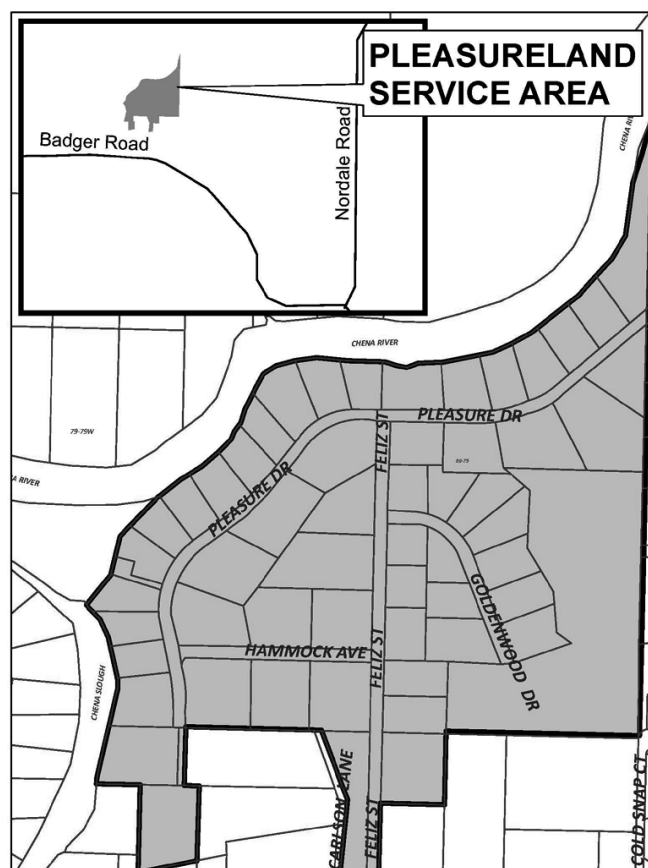

PROPOSED TAX CAP REVISION PLEASURELAND SERVICE AREA



PROPOSITION

“Shall the Pleasureland Service Area be authorized to increase its annual property tax revenue in the amount of \$3,850 in order to fund road maintenance and capital construction services?”

FAIRBANKS NORTH STAR BOROUGH ABSENTEE BALLOT APPLICATION

GENERAL INFORMATION

Service area elections are held twice annually, in November for establishing, dissolving or to consolidate or merge two or more service areas, and in March to adjust a service area's mill levy for services provided within the boundaries of the service area, and when the assembly, by motion, resolution, or adoption of an ordinance calls for a special election.

VOTING IN PERSON

Absentee in person voting for the **March 26, 2019** service area election begins **February 19, 2019** and continues up to 5:00 p.m. on election day. If you will be in the Fairbanks North Star Borough on or after February 19, 2019, you may cast a ballot in person Monday through Friday 8:00 a.m. to 5:00 p.m. excluding holidays and weekends at the Borough Clerk's Office, 907 Terminal Street, Fairbanks, Alaska. **You do not have to complete this application if you wish to vote absentee in person.** Call (907) 459-1401 for more information.

VOTING BY MAIL/FAX/EMAIL - BALLOT APPLICATION INSTRUCTIONS

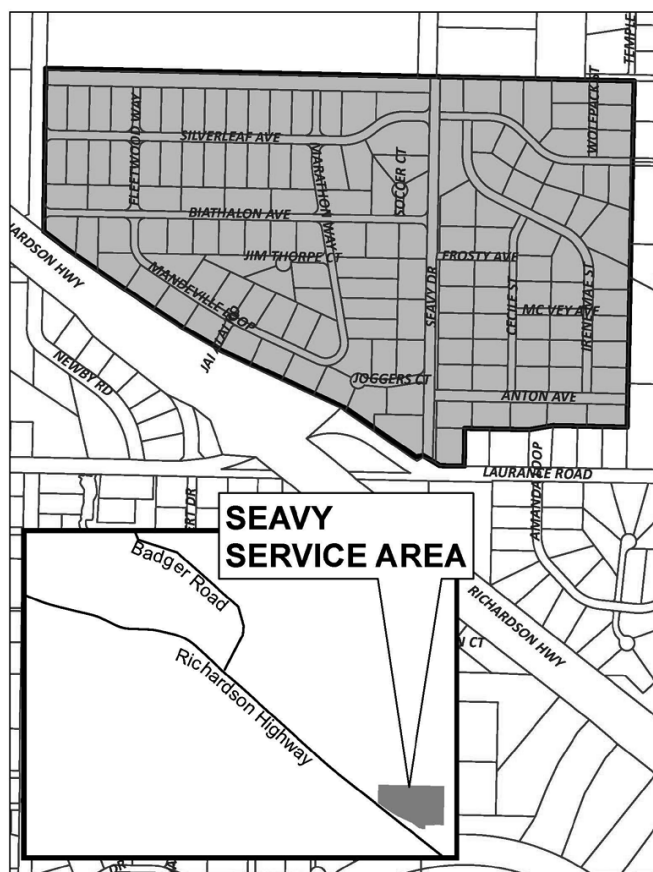
- **Absentee Voting:**
 - o **By Mail** - Your application must be received at least 7 days prior to the election. APPLY EARLY to be sure you receive your ballot in time.
 - o **By Electronic Transmission** - Your application must be received no later than 12 p.m. Alaska Standard Time on the day immediately preceding the election. Note: Absentee voters requesting ballots by electronic transmission via email are required to print both the ballot and voter's oath.
- Complete ALL information requested. Omissions may result in your application being rejected.
- **You MUST provide your residence address in the Fairbanks North Star Borough.** Use the description of physical location - street number, apt. #, etc.
- **NOTICE TO ACTIVE DUTY MILITARY PERSONNEL:** To remain registered in Alaska you must be an Alaska resident and provide your physical residence address within the State. If you have been assigned to an active duty station outside Alaska, you may wish to maintain your Alaskan residence address as it appears on your current registration record. If you provide a new residence address, it must be within the Fairbanks North Star Borough.
- **SIGN** your application. Signature must be a handwritten signature. A typed or digital signature is not valid. A friend, spouse or parent may not sign for you. **If two individuals are requesting a ballot on the same application BOTH must sign the application.**

PROPOSED TAX CAP REVISION SEAVY SERVICE AREA



PROPOSITION

“Shall the Seavy Service Area be authorized to increase its annual property tax revenue in the amount of \$11,780 in order to fund road maintenance and capital construction services?”

An increase of \$11,780 will add approximately 0.37 mills to the rate allowed by the existing tax revenue cap.

VOTER QUALIFICATIONS

A person is qualified to vote in service area elections who:

- A.
 1. Is a citizen of the United States;
 2. Is 18 years of age or older;
 3. Has been a resident of the borough and the precinct in which the person seeks to vote for at least 30 days just before the election;
 4. Is registered to vote in state elections at a residence address within a municipality at least 30 days before the election at which the person seeks to vote;
 5. Has registered before the election as required under AS 15.07 and is not registered to vote in another jurisdiction; and
 6. Is not disqualified under Article V of the State Constitution.
- B. A person is qualified to vote in a service area election if he meets the requirements of subsection (A) of this section and has in addition been a resident of the service area in which he seeks to vote for at least 30 days immediately preceding the election.

INSTRUCTIONS FOR REGISTRATION:

You may update your voter registration at www.elections.state.ak.us/ or in person at the State Division office at 675 7th Avenue, Station H3, or at the Borough Clerk's office during normal business hours.

Voters have 2 options to cast a ballot:

1. In person at the Borough Clerk's Office during regular hours from 8:00 a.m. - 5:00 p.m., beginning **Tuesday, February 19, 2019** THROUGH ELECTION DAY. (Excluding weekends and holidays).
2. Request a ballot by mail, facsimile, or email. Ballot Applications must be in writing. An application for an absentee ballot by mail must be postmarked not less than seven days before the election for which the ballot is sought. An application for ballot by facsimile or email must be received by the Clerk no later than 12:00 p.m. the day immediately preceding the election.
